Coordinated launch of our Members' Commitments

Many thanks to everyone who has contributed to the development of our <u>list of ten priorities for</u> <u>members to do</u>. Early next year, we plan to coordinate the launch of our members' commitment – we'll be discussing how we can work together to do this at the monthly comms/policy meeting next week, so please do ensure someone from your organisation is able to attend. At the meeting we'll discuss:

- What to call the list of commitments/pledge
- When to launch
- How to launch (e.g. with a coordinated announcement by all members, etc.)

Clean Air and Environment Targets

On 7 November, we joined with Link, Greener UK and the Healthy Air Coalition in a <u>formal complaint</u> to DEFRA regarding the government's failure to meet the deadline to publish environment targets. A response from the Environment Targets team received later in November advised that the department would continue to work at pace to lay draft statutory instruments, but no specific timetable was provided. Greener UK, Healthy Air Coalition, and Wildlife and Countryside Link, have subsequently submitted a formal complaint to the Office for Environmental Protection on this legal breach and the lack of a specific timetable to remedy it.

On 8 November, we were co-signatories with the Healthy Air Campaign Coalition in a letter to the Secretary of State regarding a revised plan which proposes to remove the proven charging element of a Clean Air Zone for Manchester. The letter urged for a charging CAZ be implemented and called for the proposal not to be weakened.

We have welcomed the recent announcement by the Mayor of London to expand the Ultra Low Emission Zone (ULEZ) to cover most of Greater London from August 2023. Earlier this year, we joined with 13 other organisations in a letter coordinated by Clean Cities, calling for the ULEZ expansion in delivering cleaner air in London. There is more work to be done, but this is a good step forward for London.

Sustainable healthcare conference

In partnership with BMJ, we have been successful in a proposal to NHS England, as part of their procurement on 'Clinical Insights for Net Zero Healthcare', to hold a conference on sustainable healthcare in 2023. The proposal outlined intention to deliver the following:

- 3. Produce a post-event report, which summarises themes and best practice highlighted at the conference and share the poster projects via an e-poster platform
- 4. Hold a free public webinar which summarises learning and highlights from the conference
- 5. Deliver a Greener NHS BMJ Award category on sustainability and climate impact
- 6. Create a landing page which links to e-poster abstracts and all other project outputs to provide ongoing content

A project team has been established to take this forward and we will keep you updated.

Editorial from Africa

The editorial we coordinated which called on climate justice for Africa has been referred to as an <u>unprecedented act of public speech</u>. The editorial, which was co-authored by 16 editorials of leading biomedical journals across Africa, will be published in 260 journals, including 50 from the African continent. The editorial was published in Arabic, Croatian, Dutch, English, French, Portuguese and Spanish. It was reported in 130 news stories across dozens of countries, reaching an audience of about 800 million people. A further 300 million were reached through social media. In total, this translates into advertising value of almost \$8 million.

IN CONVERSATION LUNCHTIME SESSIONS

Mobilising health professionals on air pollution

On 1 December we hosted a lunchtime session with Clean Air Specialist Dr Malcolm White and the Director of Global Action Plan, Larissa Lockwood. The session provided insights into air pollution and the UK context, insights from the national GP project, and recommendations, followed by an excellent discussion.

Key messages from the session were:

- Health professionals have an important role in providing patients with information about air pollution
- Only basic training is required to help health professionals feel confident enough to advise patients how to protect their health from air pollution
- Resources have been developed by health professionals for health professionals to aid these conversations: <u>Clean Air Knowledge Hub for the Health Sector (actionforcleanair.org.uk)</u>
- Having these conversations works following GP advice patients changed their behaviour on air pollution
- We now need these resources to be shared by all health organisations to enable health professionals to talk to patients about air pollution *Action for all to do*
- Let's look for ways to embed air pollution into medical curricula and CPD
