#### M&M Conferences

What benefits do M&M conferences provide?

- Promote MDT working
- Improve working relationships
- Assess Quality and Standards of Care
- Aim to review all Deaths within 7 days
  - review all patient safety incidents within 7 days
  - create care plans for all patients with a length of stay ≥14







### MDT involvement

- Consultant led encourage discussion and reflection in a blame free environment
- Promote transparency and culture of safety
- Nurses responsibility to cascade awareness
- AHP "invited" dependant on case SNODS, Physio, CCOT
- MDT involvement gives "holistic perspective of Patients case"
- Case review allows for critical thinking and problem solving skills in the work environment.



#### M&M

- All deaths reviewed from last 7 days
- Drs/Consultants review and score the care given.
- Score 1-6. 1 = unsatisfactory, 6 = very best care.
- Review "adverse events"/near misses in a blame free, transparent culture
- Evaluate how the system of care affects the quality of care
- Review polices and educational tools
- Identify training needs
- Improve patient outcomes



## Patient Safety Incidents

- Patient safety is our top priority
- Improving quality of care by learning from adverse events is a lifelong activity in all domains of patient care
- Clinical Governance involvement to promote trust-wide improvements
- Share PSI with Critical Care Network
- Feedback to staff
- Research suggests a continuous reflection, education and action process of safety events is associated with a reduction of PSI
- Drive Q.I initiatives
- An ongoing commitment to patient safety results in significant improvements overtime

"MSM meetings can be used effectively to teach principles of patient safety and create system-wide improvements".



## **Long Term Patients**

- LOS ≥14days
- "Handover" between Consultants/trainees
- Is appropriate plan of care in place?
- Is the right consultant in charge of the patient?
- Weekly MDT meetings feed into M&M meetings
- Discharge & rehab co-ordinator
- CCOT/Physios/OT





## Summary

- Initial feedback lots of Navy/Dr's
- Dr's more relaxed/open encourages all staff to follow this lead.
- Allows for individualised holistic care long term patients
- Both medical/nursing ideas considered
- Allows for closure
- Feedback offered to staff who cannot attend
- Improvements made for care of future patients and to reduce PSI
- Promotes MDT working each case can affect everyone differently – M&M allows for reflection of this.
